## WILTSHIRE WASTE & RECYCLING CONTRACT HILLS RECYCLING REPORT – JUL to SEP 2011 WASTE & RECYCLING STATISTICS

### 1.1 **QUARTER 2 2011/12**

#### 1.1.1 Summary

Quarter 2 produced 65,436 tonnes of contract waste and landfill diversion of 32,374 tonnes - a landfill diversion rate of 49.3%. A further 12,522 tonnes of municipal waste was sent to Lakeside for energy recovery.

#### 1.1.2 HRCs


HRC tonnage represented 47.1% of the recycled tonnage in the quarter. HRC recycling rates in the quarter ranged from 72.3% to 82.4%, average 80.47%, and contributed 15,200 tonnes of landfill diversion.

#### 1.1.3 Multi-Material Kerbside

In the quarter 5,763 tonnes of material was collected. Performance is down on last year.



Preparation of Street Level Risk Assessments for the County has started and assessments will commence Monday 31st October on all rounds.

Alongside the positive publicity there have been a number of press articles relating to the planning applications for Ludgershall, Porte Marsh and Lower Compton.
